

**INVESTMENT OBJECTIVE**

The objective of the fund is to provide capital growth, with the potential for income, over any 7-year period. We aim to achieve this through systematic exposure to shares across any economic sector and geographic area. The systematic approach is defined as using a methodical rule-based investment process to create the asset allocation and underlying investment selections.

To provide the above exposure, a minimum of 70% of the fund will be invested in active and/or passively managed collective investment schemes

**INVESTMENT POLICY**

A systematic approach is used to provide exposure to shares across any economic sector and geographic area. The systematic approach is defined as using a methodical rule-based investment process to create the asset allocation and underlying investment selections.

A minimum of 70% of the fund will be invested in collective investment schemes (which may include schemes operated by the ACD, associates or controllers of the ACD).

The fund may also invest directly (maximum of 30%) in transferable securities, such as shares and investment trusts.

The fund will be fully invested except for a cash amount to enable ready settlement of liabilities (including redemption of units) and efficient management of the fund both generally and in relation to its investment objective. This amount will vary depending upon prevailing circumstances and would not normally exceed 10% of the total value of the fund.

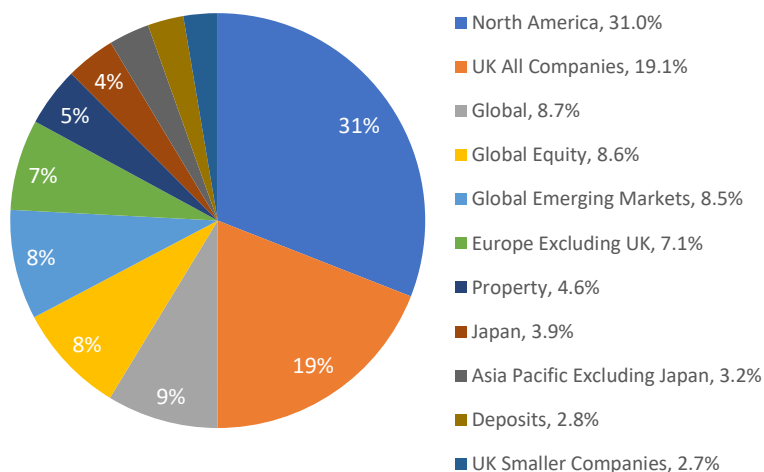

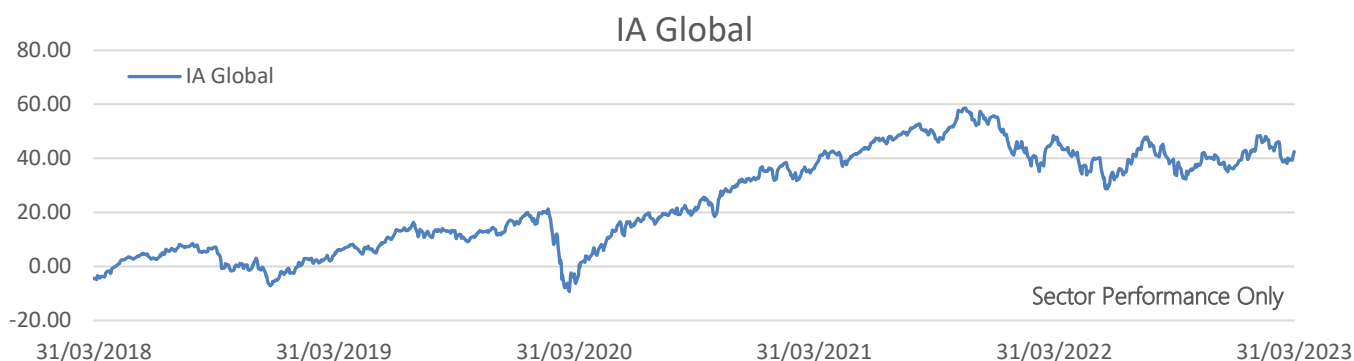
